Directions to the Kathy's:

From North or South I-5, take Exit **194** (US-2) heading East. Take the **20th St. SE Exit** ramp.

Continue East on **20th St. SE** for aprox. 1.6 miles, cross **Rt. 9** and continue on **20th St SE** for 2.4 miles. Turn **right** onto **Machias Cutoff Rd**, which changes name to **S. Machias Rd**, go 1.3 miles.

At gas station turn **right** onto **OK Mill Rd**, go 1.6 miles. Turn **left** onto **Newberg Rd**, go .9 miles.

After S-turn on Newberg, turn **left** on **14th St NE**. Turn **right** on **159th Ave NE**, turn **right** on **23rd St NE**, turn **left** on **161st Ave NE**. Draft match is at second property on the right with 3 rail fence.

Note *The field being used for the match will be in full sun, please bring chairs and pop-ups. A hose for water is available on site.*
